b) Discussion and adoption of the new Cross-Connection Control Policy Handbook, effective July 1, 2024. The Handbook will supersede the current cross connection control regulations for public water systems in the California Code of Regulations, Title 17. The Handbook has some new requirements that will necessitate re-evaluating and expanding your cross-connection control program. Specifically, it requires submittal of a written Cross Connection Control Plan no later than 12 months after the Handbook's by July 1, 2025.

c) Approval to update VSPUD Rules & Regulations to ensure compliance with the new State Regulations and Backflow Compliance.
